#### ANNOUNCEMENT

Sub: Important Message: Strict Compliance - regarding Verification/ Clarification of documents related to incorporation of a Company or a LLP by Practicing Professionals.

The MCA has communicated to ICAI that instances have been observed where practising professionals are not carrying out Due Diligence and Verification while carrying out incorporation of Company / LLP. The Verification of documents pertaining to Directors, KMP, witness to MoA, AoA and verification of Registered Office are required to be done in strict accordance with the provisions of Law.

Members may accordingly ensure strict compliance to avoid penal actions.

## **Law Updates**

#### Companies Act

- 1. Clarification on passing of Ordinary and Special resolutions by the companies Act,2013 read with rules made thereunder on account of COVID-19 Extension of timeline.
  - Companies are allowed to conduct AGMs or EGMs through Video Conference or Other Audio Visual means upto 31<sup>st</sup> December 2022.
- 2. Last Date for filing of LLP Form 11 without paying additional fee has been extended upto 15<sup>th</sup> July,2022.

## Goods And Service Tax Act

1. The government issued a notification on Saturday extending the goods and services tax (GST) compensation cess until March 31, 2026. The cess was to end on June 30, 2022, five years after the single tax rolled out on July 1, 2017.

## Income Tax Act

- 1. E-filing of Tax Audit Report Form 3CA-3CD and 3CB-3CD for AY 2022-23 is enabled by Income Tax Portal.
- 2. Form 26A, Form 27BA, Form 10BD and Form 10BE are available for filing on the portal.
- 3. Income-Tax (Eighth Amendment) Rules, 2022 Amendment in Rules 2F and 8b; Substitution of Form No. 5B; Insertion of Form No. 5BA Notification G.S.R. 275(E) [No. 28/2022/F. No. 370142/4/2022-TPL], Dated 6-4-2022 The above notification has been issued to enable the Infrastructure Debt Fund to issue, (i) Rupee denominated bonds or foreign currency bonds in accordance with the directions of Reserve Bank of India and the relevant regulations under the Foreign Exchange Management (Transfer or Issue of Security by a Person Resident outside India)Regulations, 2000, as amended from time to time; or (ii) Zero coupon bonds in accordance with rule 8B Consequential amendments and substitutions have been done in Rule 2F and 8B. Further Form no 5B has been substituted and Form No 5BA has been inserted.
