Editorial Message

Dear Members,

ICAI has come up with multiple arrangements for benefit of the members in practice. Recently, it has arranged 'all-in-one accounting software' — A cloud based accounting and compliance solution. The MCA has issued the Companies (Auditor's Report) Order, 2020 (CARO 2020), on 25th February 2020 in supersession of the Companies (Auditor's Report) Order, 2016. The same is applicable from the audit of the Financial Year 2019-20. To strengthen the corporate governance framework and to improve the

overall quality of reporting by the auditors, MCA has proposed significant changes in the CARO 2020. Through this MCA has put additional responsibility on the Auditors with their audit.

The Government has given last chance to link the PAN with Aadhar by 31st March 2020. The PAN may become inoperative if not linked to Aadhar. Also there is a penalty for inoperative PAN. Coming to GST, an important development is going to take place from 01st April 2020, when certain category of taxpayers is required to generate e-invoice. Also new return forms will be applicable with more clarity and ease for the taxpayers. With these developments, we can understand how the Government is focusing more and more on digital environment. Hence, we professionals are required to keep ourselves regularly updated to understand these changes and applying it in our practice.



The Honorable Prime Minister of India has communicated to the citizens of India that this year he will not participate in any Holi event due to the amid coronavirus scare. As responsible citizens of the country, we too should be careful and avoid any gatherings to avoid the spread of COVID-19 Novel Coronavirus.
