CBIC vide Notification No. 1/2022, has extended e-invoicing system to those taxpayers, whose annual aggregate turnover is above Rs. 20 Cr, with effect from April 01, 2022. The exclusion of SEZ and other classes of taxpayers such as banks, financial institutions, GTA etc. continues. The main motive of the Government behind the decision for implementing E-invoicing is to achieve complete digitization and increase the business efficiency by lowering the processing cost of the documents. Many MSME's will now have to prepare themselves for issuance of e-invoicing with the reduction in limits.

The 3rd wave of covid-19 started at the end of November, 2021. It saw the number of cases incrementing in mid-January to around 3 lakh new cases. However, due to the lower severity of the new 'Omicron' variant, with most cases being asymptomatic or experiencing mild symptoms, the impact of the same has been much lesser in comparison to the previous waves. There was also an acceleration in the vaccination process, which may have led to the lower severity. However, one cannot rule out the continuation of taking precautionary measures.

With the month of March arrives the festival of colours, Holi; celebrating the triumph of good over evil. Its vibrancy brings back new energy and endurance. The editorial board wishes all its members a Happy and Safe Holi and a Happy Financial Year end. With God's grace and the blessing of our members, we hope to make the branch and its members proud by our achievements.


